OBSERVATIONS

The company was used to supply casual labour to various furniture removal businesses.

In March 2002, Garry Snedden became ill and was unable to work in the business. In August 2002 it became obvious that Mr Snedden was unlikely to recover sufficiently enough to resume his duties.

The decision was made to sell the assets of the furniture removal businesses. A buyer was found and a contract negotiated. Settlement took place on the 13th September 2002.

A result of the sale was that the labour hire business was no longer required and it ceased to employ.

LIQUIDATION COMMITTEE

At any time during the liquidation, any creditor may in writing request the Liquidator to call a meeting of creditors to consider whether a Liquidation Committee should be appointed, and if so, to choose the members of the committee.

A Liquidation Committee has certain powers set out in s315 of the Companies Act 1993, including to assist the Liquidator as appropriate in the conduct of the liquidation.
