**Liquidator's Final Report**

Gerard Hulst was appointed Liquidator of the above company by order of the High Court at Auckland on 1 June 2000.

**Actions of the Liquidator**

The first report to creditors was dated 23 June 2000.

I have followed up all outstanding issues and report as follows:

1. A significant amount of time and effort went into the recovery of the shareholder's current account balance, which was paid in full on 28 May 2003.
2. The funds recovered have covered the costs of the liquidation proceedings.
3. There is no financial benefit to creditors in continuing with the liquidation.
