**Liquidator's Final Report**  
*pursuant to section 257 of the Companies Act 1993*

**to the Creditors and Shareholders of**

**Intercity Movers 2000 Limited (In Liquidation)**

Gerard Hulst was appointed Liquidator of the above company by special resolution of the shareholders on the 11<sup>th</sup> day of June 2001.

**Actions of the Liquidator**

The first report to creditors was dated 18 June 2001.

Since the Liquidator's last report I have managed to receive payment from two debtors. The remaining debtors are considered to be unrecoverable.

The motor vehicles that were transferred to AAA Movers Limited and were subject to Hire Purchase agreements have been repossessed by the finance companies. Owing to insufficient funds in this liquidation, any litigation to recover the equity in these vehicles is not possible.

The only motor vehicle owned by the company has been sold.

There are no outstanding issues.

The liquidation of the company is now complete and the Liquidator states:

## **Notice of Intention to remove Company from the Register**
