Liquidator's Final Report

All Brand Service Limited (In Liquidation)

Gerard Hulst was appointed Liquidator of the above company by order of the High Court at Auckland on the 8th of October 1998.

Actions of the Liquidator

The first report to creditors was dated the 13th of November 1998.

We have followed up all outstanding issues and report as follows:

On 1 September 1998 All Brand Services Limited put the company's assets up for sale by public auction. The sale proceeds were paid to the bank. As the bank's security was a floating charge I was able to recover funds pursuant to the voidable preference provisions of the Companies Act.

A professional debt collection firm was engaged to collect debtors.

The company was closely associated with International Copiers Limited (In Liquidation) and the accounting was intertwined.

After the auction Mr O'Malley commenced trading as a copier repair business. He took the customer database of All Brand Copiers Limited and continued to service those clients. The database was valued at \$400,000. A lack of accounting records thwarted my efforts to establish that Mr O'Malley had personally gained from the Goodwill.

The liquidation of the company is now complete and the Liquidator states:

Notice of Intention to remove Company from the Register
