**Liquidator's Final Report**  
*pursuant to section 257 of the Companies Act 1993*

**to the Creditors and Shareholders of**  
**Internet NZ Limited (In Liquidation)**

Gerard Hulst was appointed Liquidator of the above company by order of the High Court at Auckland on 4 November 1999.

**Actions of the Liquidator**

The first report to creditors was dated 9 December 1999.

I have followed up all outstanding issues and report as follows:

1. An investigation into the affairs of the company revealed that 347 individual contracts, totalling \$138,053.08, were entered into by the company for the direct benefit of its shareholder, Detlef Hebbel.
2. Correspondence sent to Mr Hebbel regarding this debt has not been returned or responded to.
3. On 4 December 2002 I deemed \$138,058.03 as a dividend to Detlef HEBBEL for the year ended 31 March 2000.
4. There is no financial benefit to creditors in continuing with the liquidation.

**Statement of Realisations and Distributions**

*pursuant to s257 of the Companies Act 1993*

There were no Realisations and Distributions during this liquidation.

**General Comments**

The liquidation of the company is now complete and the Liquidator states:

1. All known assets have been disclaimed or realised or distributed without realisation, and
2. All proceeds of realisation have been distributed, and
3. A statement of Realisation and Distribution is included in the report.
4. The company is ready to be removed from the New Zealand Register.

## **Notice of Intention to remove Company from the Register**

I, Gerard Hulst, Chartered Accountant of Auckland, Liquidator of Internet New Zealand Limited (In Liquidation), whose registered office is situated at 26 Hobson Street, Auckland, hereby give notice that, pursuant to section 320 of the Companies Act 1993 and having filed with the Registrar my final report on the Liquidation, it is intended to remove the Company from the New Zealand Register.
